The organisation seeks to establish a robust knowledge and learning infrastructure that enables real-time data capture and strategic inputs for intervention design and policy reform through evidence-based decision-making and reflective action. The research and knowledge management initiatives of BRLF scaffold effective engagement of key stakeholders with the existing body of knowledge and enable optimum opportunities for crafting self-learning systems and processes.

In this regard, BRLF is committed to creating knowledge and practice support resources that enhance the outcomes of sustainable livelihood initiatives by the government and CSOs. As part of this commitment, BRLF is creating analytical case studies documenting learnings from on-ground interventions by BRLF and its partners. The case studies shall capture in-depth key intervention prototypes that enhance the outcomes of livelihood initiatives and policy instruments.

To facilitate this initiative, BRLF would like to procure two part-time case study writing consultants with extensive proven experience in publishing case studies in the non-profit sector.

Scope of Work

The consultant's scope of work shall include building case narratives and writing case studies based on primary and secondary data collected by the BRLF research team. The cases written by the case writers shall be published as co-authored BRLF knowledge assets under Creative Commons Licensing 4.0.

Nature of Engagement:

- 1. Remote with Field Visit.
- 2. Key Responsibilities:
 - a. Co-authoring 2 case studies
 - b. Technical inputs into existing case studies that feature key BRLF prototypes on the Partnership model and Agricultural Production Clusters
 - c. Field visit to BRLF project sites in Odisha
 - d. Review and technical inputs in 5 BRLF case studies.
